Economic and Commercial Report for December 2016

- On 5 December, the Eurogroup approved short term relief measures for the Greek debt. On 14 December, the European Stability Mechanism (ESM) discontinued the implementation of the short-term debt relief measures due to the announcement of the Greek Government to give one-off Christmas bonus to low-income pensioners and the suspension of the value-added tax rise for the eastern Aegean islands for one year. The issue will be discussed in the next Eurogroup meeting on 12 January 2017.
- According to the Ministry of Finance, the State Budget Execution for the January to November of 2016 showed a primary budget surplus amounting to €7,416mil (€3,863mil higher than the target). The net revenues showed a rise of €1,501mil higher than the target and amounted to €47,942mil. The State Budget expenditures decreased by €2,373mil compared to the target and amounted to €45,919mil.
- ➤ According to the Bank of Greece (on 8 December) the European Central Bank agreed to reduce the **emergency liquidity assistance** (ELA) by €0.2billion from €50.9billion to €50.7billion.
- On 22 December European Investment Bank (EIB) sanctioned a €1billion credit line to Greek banks. The first €400million will be given to Alpha Bank, Eurobank, National Bank of Greece and Piraeus Bank equally. The remaining €600million will be given in 2017-2018. The funds will be used to provide loans to small and medium-sized businesses in agriculture, tourism, manufacturing, services and other sectors in order to promote youth employment.
- The total imports in October 2016 amounted to €4,086.4million recording a decrease of 5.3% compared with October 2015. The total exports in October 2016 were €2,343.4million with an increase of 4.8% compared with October 2015. The trade deficit in October 2016 was €1,743.0million recording a drop of 16.1% compared with October 2015. (www.statistics.gr)
- The Consumer Price Index (CPI) in November 2016 decreased by 0.9% compared to November 2015 and decreased by 1.2% compared with October 2016. (www.statistics.gr)
- ➤ The **Production Index in Industry** (IPI) in October 2016 increased by 6.8% compared with October 2015. (www.statistics.gr)



- The Overall **Turnover Index in Industry** (both domestic and non-domestic market) in October 2016 decreased by 2.8% and 9.7% compared with October 2015 and September 2016 respectively. (www.statistics.gr)
- ➤ The Greek Merchant Fleet, for vessels of 100 GRT, in October 2016 increased by 0.3% compared with October 2015. The gross tonnage of the Greek Merchant Fleet, for vessels of 100 GRT and over, in October 2016 increased by 0.6% compared with October 2015. (www.statistics.gr)
- The unemployment rate, in the third quarter of 2016, was 22.6% compared to 23.1% in the second quarter of 2016 and 24% in the same quarter of 2015. The number of employed (3,736,715 persons) increased by 0.9% and 1.8% compared with the second quarter of 2016 and third quarter of 2015 respectively. The number of unemployed (1,092,589 persons) decreased by 1.8% and 5.9% compared with the second quarter of 2016 and third quarter 2015 respectively.

✓ On 8 December "Corinth Pipeworks S.A." (a world leading manufacturer of steel pipes and hollow section to the oil, gas and construction sectors) and "Hellenic Cables S.A." (the largest cable producer in Europe) was taken over by "Cenergy Holdings S.A" (a Belgian public limited liability company) as a result of a cross-border merger. The Cenergy Holdings S.A. becomes the parent company of a Group of companies, which are active in the production, distribution and marketing of steel pipes and cables. (Source: Greek Press)

- ✓ "Aktor S.A." (one of the largest construction companies in Greece) on 15 December won the tender for the first phase of regeneration works at Faliro Bay, Athens for €80.3million. The company offered 53.54% discount on the budgeted cost thus saving public money. (Source: Greek Press)
- ✓ According to the annual report of Petrofin Research for 2016, announced on 15 December, the number of the Greek shipping companies decreased by 1.5% from 648 (2015) to 638 (2016). The Greek owned fleet increased with 5,230 vessels from 4,909 in 2015, as well its share in the world fleet from 16.05% (2015) to 16.36% (2016) proving the ability of Greek Shipping to continue growing and investing despite the economic crisis. Companies with 25+ vessels constituted 65.38% of the total Greek fleet in DWT terms and the number of the companies that run them increased to 46 instead of 41 in 2015. Also the very young vessels increased to 73.56% of the total in comparison with 73.47% in 2015. Companies with 1-2 vessels constituted 41.54% of the total companies compared to 40.43% in 2015. The age for all vessels decreased to 12.19years from 12.73 in 2015. (Source: Greek Press)
- According to the annual Lloyd's list of 100 persons having greatest influence in global shipping, Greek shippers holds 14 positions. The highest ranked Greek is John Aggelicoussis of Aggelicoussis Shipping Group, who holds 7th position; followed by George Prokopiou of Dynagas (12th position), Angeliki Frangou of Navios (19th), George Ekonomou of Dryships (20th), Peter G. Livanos of GasLog/Ceres Shipping (23rd), Petros Pappas of Star Bulk (35th), Nikolas Tsakos of Tsakos Energy Navigation (42nd), Kostis Konstantakopoulos of Costamare (50th), Theodore Veniamis of Union of Greek Shipowners (53rd), Petros Geogriopoulos of Gener8 Maritime (60th), Evangelos Marinakis of Capital Maritime & trading (61st), John Platsidakis of Intercargo (81st), Simos Palios of Diana Shipping (95th) and Polys Chajioanou of Safe Bulkers (96th). - ✓ The "Angelicoussis Shipping Group" made an order of a liquefied natural gas floating storage and regasification unit (LNG-FSRU) from the Korea's Daewoo Shipbuilding and Marine Engineering, which will cost US \$ 300million. LNG-FSRU supplies natural gas without ground gasification facilities, a less costly solution compared to permanent land based infrastructure. (Source: Greek Press)
- ✓ According to Allied Shipbroking in 2016, the Greek shipowners and Greek shipping companies ranked first in the second hand vessel market. Specifically, Greek interests invested €3.46billion for purchase of 269 vessels (vessels already under construction, second hand ships-bulk carriers, tankers and container transports) and on the other hand sold 165 second hand vessels with transactions valued at more than US \$2billion. - ✓ Intralot Inc. Greece, a subsidiary of Intralot Group ofUnited States, selected on 9 December by Idaho Lottery as the Apparent Successful Vendor to provide Lottery Gaming System services for 10 years with the option to extend for up to a maximum of two additional five-year terms. The initial term of the contract is valuated at US \$60million. (Source: Greek Press)
- ✓ The Greek coffee company "Coffee Island" on 8 December announced the opening of
 its first coffee shop in London. The decision of the company showed its vision to go
 beyond the borders of the country and compete dynamically in the British market,
