ANNUAL ECONOMIC & COMMERCIAL REPORT: 2022

1. OVERVIEW

The economy likely shrank for the fifth consecutive year in 2022 due to ongoing economic crisis and socio-political crises. The official exchange rate was repegged at LBP 15,000 per USD in February 2023, and in recent days the Sayrafa rate and the payment rate for customs tariffs were devalued to LBP 70,000 and 45,000 per USD respectively. The lack of a new president and cabinet continues to paralyze crucial reforms. Import from India increased by 131% in 2022 as per Lebanese Customs. Import from Lebanon by India is more than double in the current financial year as per D/o Commerce.

4. Bilateral:

The Bilateral Trade shown a declining trend between 2019-20 and 2020-21. The reason for this downward trend in bilateral trades are deep economic crisis in Lebanon. Total volume of trade between India and Lebanon during financial year 2022-23 was \$ 626 million with Indian exports to Lebanon at \$ 608 million and Indian imports from Lebanon at \$18

million. The exports have shown more than 131% increase in the year 2022 as per data from Lebanese Customs.

Export to Lebanon from India = US\$ 608 mn. (3.13% of India's export) Import from Lebanon = US\$ 18 mn. (0.42% of India's import)

(ix) Technology Collaborations/ Joint Ventures:

- Lebanon has very small and rudimentary economy. The country, which relies on imports for almost 85% of its requirement and has almost no manufacturing base, in general has no significant technology which can be benefit us.
- A number of Lebanese companies have their presence in India including Dar Al Handasaa (architecture consultant and project monitoring), Khatib and Alamy (architecture consultant and project monitoring) and Future Pipes.
- Target Food is a ready made food company engaged with an Indian company and started to import Basmati Rice
- Abido contacted some companies and received some samples of spices and spices raw materials, converting the samples into an actual order with a contact amounted around 60,000\$ that has been shipped to them. This shipment is just the beginning of a long term business relationship with their new Indian partner "Nani Agro".
- Masrilivestock is a company for frozen meat had cooperated with one Indian company and started to import Frozen Meat
- Choueiry Group in Lebanon signed a contract with Hinduja Group for importing Ashok Leyland Trucks to Lebanon.
- Ouzanian company for Jewelry is importing precious and semi precious stones from India
- An Indian power management company OEG, won the award for maintenance of two
 power plants in Lebanon along with its Lebanese partner, MEP in 2018. The company
 has been successfully managing two power plants in Jiyeh and Zoukh since 2018.
- A.N. Boukhather SAL (ANB Holdings), is the representative of Bajaj Motors in Lebanon, dealing in 2 and 3 wheeler for a long time. In 2021 ANB has set up an assembly plant to assemble Bajaj 2 wheeler, adding local design features to market it in Lebanon. This is a significant technology collaboration. Given the economic crisis in

Lebanon , there is a huge growth potential of 2 and 3 wheeler as cost-effective transport solutions.

- Recently, an investor from Lebanon (Al Nabeel Foods) has shown interest in investing
 in India in Humus making factory, both for the Indian Market and for export purposes.
 The Embassy has put the potential investor in touch with Invest India team and is
 following up the matter.
- A Lebanese company, Benta Pharmaceutical has established its entire production line based on Indian machinery. The company also import significant quantities of APIs from India. The Embassy was also able to identify supplies of Remdesivir (M/s Arwan Pharmaceutical Industries) and ventilators (M/s Phoenix Group) during the Delta Covid wave in India in May 2021.

4. INTERNAL

(a) Economy

(i) Industry and Agriculture

The agriculture and industry sectors, which have been under pressure due to their heavy reliance on raw material, the spillovers of the depreciation of the currency and the increase in prices globally, took a relative respite recently due to a slightly recovering demand component amid the emergence from the previous year's Corona lock downs.

(ii) Unemployment

Lebanon's official unemployment rate has nearly tripled in fewer than three years since the start of the country's devastating economic crisis, a survey has found. "Lebanon's unemployment rate increased from 11.4 per cent in 2018-2019 to 29.6 per cent in January 2022.

(iii) Inflation

It is worth mentioning that the depreciation of the exchange rate has very significant inflationary spillovers, which increased the proportion of households below the poverty line to around 74%. The cumulative inflation reached circa 1,500%. Lebanon's inflation reporting three-digit rates.

(b) Trade and Services

(i) Trade Balance

After three years of crisis, despite the collapse of the national currency, imports have returned to their pre-crisis level, while the trade deficit continues to widen in view of the fall in exports. On the export side, the trade balance shows a decline of nearly \$395 million from the previous year, reaching \$3.49 billion by the end of 2022, marking an annual decline of 10.16 percent.

(c) Banking

(i) Banking Activity: FX deposits and FX loans both drop by US\$ 28 billion since crisis onset

The cumulative banking sector analysis since the onset of Lebanon's financial crisis, i.e between October 2019 and December 2022, shows that FX deposits contracted by US\$ 28.0 billion and FX loans dropped by US\$ 28.0 billion respectively, while banks FX liquidity dropped by US\$ 4.2 billion within the context of a cumulative balance of payment deficit of US\$ 15.4 billion.

(ii) Equity and Bond Markets

Extended equity price rally in 2022 on hedging activity, bond prices plunging to mid-single digit levels on prolonged institutional vacuum and tough reform road

Lebanon's equity market continued to register strong price gains in domestic US dollar terms in 2022, as market players continued to flock to realty stocks to hedge against crisis. On the other hand, the Eurobond market plunged deeper into the red amid a protracted multi-layered institutional void and tough reform challenges to reach a full fledge agreement with the IMF and unlock much-needed international financial support.

(iii) Lebanon Economic Monitor: Time for an Equitable Banking Resolution

The Fall 2022 issue of the LEM presents the World Bank's latest macroeconomic projections for 2022, within a prolonged context of uncertainty and institutional vacuum. It highlights the main bottlenecks prohibiting a comprehensive solution, with a particular focus on the discord amongst stakeholders on the distribution of financial losses-owing to the magnitude of losses in the financial sector. Inflation is expected to average 186 percent in 2022, amongst the highest globally, partly due to the shrinking share of imports based on BdL subsidized rates.

(d) Finance

(i) Monetary Situation: LP on downward spiral amid darkened political outlook and tough reform challenges

The year 2022 saw the Lebanese pound plummet to new lows against the US dollar on the parallel FX market, which compounded with a large expansion in the money in circulation outside BDL and continuous FX reserves burn. This occurred despite all exceptional measures adopted by the Central Bank of Lebanon since late 2021 to curb currency collapse, allowing banks to purchase US dollar banknotes from BDL at the "Sayrafa" rate.

(ii) Lebanese Sayrafa Volume and Lebanese Market Exchange Rate

In the Economic Digest published in this Blog on February 23, 2023, titled "Preliminary Observations on Lebanese Monetary Aggregates and Monetary Policy during the Crisis", we mentioned that the Sayrafa platform – which was activated vigorously in December 2021 – was intended to absorb LBP liquidity and slow down the depreciation of the exchange rate. There are 3 variables: the parallel market rate against the US dollar in LBP is the dependent variable; the Sayrafa trading volume in US dollars and the Sayrafa rate in LBP are the two independent variables.

(iii) Lebanon to benefit from the equivalent of \$900m in IMF Special Drawing Rights

The Ministry of Finance declared that the International Monetary Fund (IMF) is discussing the allocation of the equivalent of \$650bn in special drawing rights (SDRs) to its member

countries, and that the IMF's Board of Governors, the highest decision-making body at the Fund, is considering the proposal this month and could approve the allocations by the end of August. It added that, in case the IMF's Board of Governors approves the proposal, Lebanon would receive the equivalent of \$900m in SDRs, and that Lebanon would decide how to benefit from the new allocation.

(e) Budget and Taxes

(i) Lebanon's new budget

A drastic tax hike is planned in Lebanon's 2022 budget to boost the crisis-riddled state's revenue. This is part of a yearly budget published in mid-November that has been put into effect. The budget includes LL37.71 trillion in current expenses and LL3.17 trillion in capital expenditures for a total of LL40.87 trillion. The budget also states a 15,000 lira rate to the dollar, while the market rate passes 40,000 lira to one dollar.

(f) Infrastructure, Real Estate and Construction

(i) Real Estate Sector

According to the data from the Orders of Engineers in Beirut and Tripoli, the total construction permits witnessed a year-on-year (YOY) significant jump of 219.15% to reach 1,583 permits for the second month of 2022. Notably, the Construction Area Authorized by Permits (CAP) soared by an annual 258.19% to 816,784 square meters (sqm), mainly reflecting both the high interest of investors towards real tangible assets, and also the adjustment trend of the sector from a low level during last year's lockdown.

(g) Transport, Port & Airport

(i) Despite 1.13% Increase in Container Activity for Port of Beirut, Lost Opportunities Threatening its Future Revenues

The latest statistics on activity at the Port of Beirut show an annual decrease of 15.03% in the revenues of the Port of Beirut (PoB) to \$6.40M by October 2021, compared to last year's \$7.54M. We note that no later data on revenue are available as per Port of Beirut statistics. In more details, and on a monthly basis, the transshipment volume of CMA CGM, one of the two major shipping lines operating at the Port of Beirut slightly decreased by 34.95% YOY to stand at 7,796 TEU in May 2022.

(iii) Number of Airport Passengers Up by yearly 34.81%

The activity at Rafic Hariri International Airport improved remarkably in January 2023 compared to the same period last year. In fact, the number of Beirut's International airport passengers added 34.81% YOY and recorded 490,266 passengers by January 2023.

(h) Energy and Environment

(i) Lebanon raises cost of electricity for first time since 1990s

Lebanon's state power company Electricite du Liban (EDL) raised the price it charges for electricity for first time since the 1990s. Lebanon has not had round-the-clock power since the 1990s and cash transfers to EDL to cover chronic losses have contributed tens of billions of dollars to the country's huge public debt. Government officials have said that increasing the price of power would allow the state to afford to purchase more fuel to fire power plants, thereby increasing supply from an hour or two per day to up to 10 hours per day.

(i) Tourism

(i) Tertiary sector on an improving trend in 2022

Lebanon's tertiary sector has seen an improved performance in 2022 as compared with 2021. This comes amid the resumption of economic activity in the country as well as an increase in tourism. Tourism has also shown a trend of improvement during the year with increases year-on-year in occupancy rate and revenue per room in Lebanon's 4 and 5 star hotels. Number of aircraft landings and take-offs from BIA has shown a year-on-year increase of 32.0% in 2022. In more details, the hospitality sub-sector in Lebanon showed improved figures in the first 11 months of 2022 according to Ernst & Young's Middle East hotel benchmark survey.

(ii) Beirut's Hotel Occupancy Rate reached 44.8%

According to Ernst & Young Middle East hotel benchmark survey, the occupancy rate in Beirut's 4- and 5-star hotels reached 44.8% percentage points (pp) in March 2022, up from last year's percentage of 27.1%.

(iii) Registered Growth in Cars Sector Driven by Optimistic Hospitality Industry

The Association of Car Importers in Lebanon (denoted as AIA) stated a slight improvement was recorded amid higher demand for new vehicles from the hospitality and car rental sectors driven by positive outlook for tourism this summer. But, this cautious optimism towards the sector remains subject to sky-high inflation and the outcome of the political situation in Lebanon.

4. <u>LEBANON EXTERNAL</u>

(a) Lebanon - Jordan

Capital Bank acquires 100% ownership of Societe Generale Bank Jordan (SGBJ) along with its wholly owned financial brokerage firm, in its second foray within a year to expand its position regionally and domestically. The board of Capital Bank in December approved the offer to acquire SGBJ, which is 87.7% owned by Societe Generale de Banque au Liban, according to SGBJ's website. It is worth noting that Societe Generale Bank Jordan is a fully

licensed Jordanian bank. Last year Capital Bank, completed its acquisition of Bank Audi Sal operations in both Iraq and Jordan in step with its expansion and diversification plans. Assets of Capital Bank grew by 45% in less than a year to around JD 6 billion (US\$ 8.5 billion). Moreover, the bank expanded to serve small and medium-sized companies and retail customers, Chairman of Capital Bank said in a statement.

(b) Italy - Lebanon

Italian Ambassador, UNDP Ink Zahle Waste Water Treatment Project In Presence Of Ministers Of Energy And Environment

Italian Ambassador to Lebanon, Nicoletta Bombardiere, accompanied by Caretaker Minister of Energy and Water, Dr. Walid Fayad, Caretaker Minister of Environment Dr. Nasser Yassin, and United Nations Development Program (UNDP) Resident Representative in Lebanon, Melanie Hauenstein visited Zahle's waste water treatment plant, where Bombardiere and Hauenstein inked "Zahle Waste Water Treatment Project". The Italian Government has provided a grant contribution of 4 Million Euros to the UNDP to implement the project and ensure the operation and maintenance of the aforementioned plant, considering the financial and economic crisis that is currently affecting Lebanon.

(d) Qatar - Lebanon

Lebanese Army Receives Second Batch Of Qatari Aid

The Lebanese Army will begin distributing monetary aid donated by the state of Qatar this week, to assist soldiers amidst the economic crisis. This is the second round of financial aid from Qatar. Earlier this year, Qatar announced its intent to donate \$60 million to the Lebanese Army, though it is unclear how much of that money was received this week.

(e) Japan - Lebanon

Japan Donates Solar Panels and Medical Supplies to Lebanon

Japan donates solar panels, medical supplies for intensive care and a system for sterilizing governmental hospitals. This donation was completed through UNOPS, as part of the Urgent Support to Critical Health Facilities in Lebanon Project, funded by the government of Japan. Lebanon has huge available potentials in the field of renewable energy that must be tackled to secure electricity and support vital sectors. The Minister of Public Health will start installing a new Department of Plastic Surgery fully equipped with the latest medical equipment and surgical techniques at the Baabda Governmental University Hospital, as mentioned in a statement.

(f) Iraq - Lebanon

Lebanon and Iraq extend fuel oil agreement for one year

The Iraqi government agreed on August 11, 2022 to extend the fuel oil agreement with Lebanese authorities for one year under the same conditions of the current arrangement. The deal stipulates that Lebanon will buy one million tons of heavy fuel oil for the benefit of the state-owned Electricité du Liban (EdL) in exchange for medical and consulting services, and Iraq will export two shipments per month to Lebanon. The volume is equivalent to one third of Lebanon's fuel oil needs for electricity production. The Ministry of Energy & Water indicated that between 75,000 tons to 85,000 tons of heavy fuel oil would be exchanged with refined fuel oil through monthly tenders for the benefit of EdL. It added that the new deal is worth about \$570m.

Circulation: as per distribution list
