Romania complies with all the EU regulations in the field of economy and trade. All the tariffs apply to all the products entering the commercial circuit of the EU single market.

Romanian implemented, new EU Regulation (EU) 2021/2246 of 15 December 2021, specifying that a health certificate is required for health supplementary products which contains plants substances (Ayurvedic medicines), document which needs to be issued by a competent authority, currently Export Inspection Agency, entity under Government, before shipment's departure. The new Regulation 2021/2246 came in force in Romania on 6th of January, 2022.

RO e-Transport system In order to increase the level of collection of taxes and duties due to the state budget, as well as preventing and combating illicit trade in goods with a high fiscal risk, The Romanian Ministry of Finance has decided to implement the RO e-Transport system as of 1 July 2022 but the obligation has been postponed for some time.

The Ministry of Finance mentioned high fiscal risk goods with assigned CN codes. In short, such goods fall into the following categories: vegetables, fruits, nuts, alcoholic beverages, mineral products (natural mineral water, sand and gravel), clothing and footwear. Failure to comply with these provisions may be punished by a fine of between EUR 1,000 and EUR 20,000. Implementation of this rule has been getting delayed because of protect from transport operators.

Regarding the import of fertilizers : Emergency ordinance no. 121/2022 regarding the establishment of measures to make available on the market some fertilizer products and for the amendment of Law no. 232/2010 regarding the import regime of fertilizer samples and fertilizers.

Considering the obligations of Romania, as a member state of the European Union, to comply with the provisions of the European Union legislation for the authorization of fertilizers in order to be included in the list of authorized fertilizers, with the mention RO-Fertilizer, for use and marketing in Romania. In order to ensure at national level the legal framework in accordance with the notification requirements of the conformity assessment bodies for fertilizer products in Romania, according to Regulation (EU) 2019/1009 of the European Parliament and of the Council which allow the transmission of information by the Ministry of Agriculture and Rural Development to the European Commission, in an interoperable and automatic way, the registration of tested and authorized fertilizer products in the European Union; the fertilizer products authorized in the pedoclimatic conditions in Romania.

Anti-dumping Duty: European Commission imposed definitive anti-dumping measures on imports of ceramic tiles originating from India for a period of five years. This follows an investigation which was initiated in December 2021 and showed that EU producers were harmed by dumped imports from India. The anti-dumping duties imposed range from 6.7% to 8.7% for ceramic tiles from India.

PNL's Ciuca: Second tranche of recovery, resilience funds will boost Romania's modernisation.

Romania's PNRR disbursement is EUR 2.8 billion, with EUR 1.86 billion as a grant and EUR 0.94 billion as a loan. Due to missed milestones, they'll receive EUR 53.36 million less. To unlock the suspended funds, they must meet milestones 129 and 133, focusing on infrastructure, healthcare, and education. So far, Romania received EUR 3.79 billion in pre-financing. The National Liberal Party aims to increase European fund absorption for community development and improved living standards.

Belgium's ABEE confirms plans for EUR 1.4 bln Li-ion batteries plant in eastern Romania

Belgian company ABEE unveiled a EUR 1.4 billion project for a Li-ion battery factory in Galati, Romania, with 22 GWh capacity. It aims to meet EU's growing demand for batteries, serving the automotive and energy storage industries. The factory aligns with Romania's vision of becoming a battery supply hub for Europe. The project will be in the Galati Free Zone and is expected to create around 8,000 jobs.

Romania's OMV Petrom acquires 710 MW of solar projects

Romanian oil company OMV Petrom has agreed to acquire a cluster of photovoltaic (PV) projects at home with a combined direct current (DC) capacity of about 710 MW from Danish developer Jantzen Renewables ApS. The deal is expected to be completed in the second quarter of 2024 when the projects will become shovel-ready. The projects have already secured access to the national electricity transmission network.

Romanian steelmaker Liberty Galati invests EUR 30mn to expand high-value added portfolio

Liberty Galati, Romania's largest steelmaker and part of the Liberty Group, announced that it was investing RON 150mn (EUR 30mn) in a cooling plant for the thick sheet rolling mill. Following the investment, the accelerated cooling plant will allow the company to strengthen its presence in the most profitable market segments, increase productivity and expand its portfolio of value-added products, the company says. It will also improve the quality of finished products for its customers in the fields of offshore, construction, shipbuilding and pressure vessels.

OMV Petrom and Hidroelectrica were most profitable companies in Romania in 2022

OMV Petrom and Romgaz, leading energy companies in southeastern Europe, will develop the Neptun Deep project, the largest natural gas project in Romania's Black Sea section. The partners plan to invest up to 4 billion euros for first gas production in four years. Romania's gas production will

double, making it the EU's largest producer and ensuring energy security. The state stands to gain 20 billion euros, and the project aims to meet gas demands from 2027. The joint development plan awaits confirmation from the National Agency for Mineral Resources.

Romania's public debt up by EUR 10 bln, or 3% of GDP during Q1

Romania's public debt increased by RON 48.8 billion or nearly EUR 10 billion during the first three months of the year, according to the latest debt report published by the Finance Ministry.

The increase accounts for some 3.4% of Romania's annual GDP, but the indebtedness ratio actually increased by only 2pp to 49.2% as the nominal GDP was updated in line with the latest quarterly data.

More than half of Romania's population to use e-commerce by 2025

Romania's e-commerce market is becoming increasingly strong in Southeastern Europe, growing faster than the global average of 16.6% per year, reaching a total value of 10 billion euros by 2025, and e-commerce will be used by 54% of the country's inhabitants, according to data from the eBook eCommerce Growth Strategies. The report also notes that revenues from the Romanian e-commerce market will reach 7 billion euros in 2023 and almost 12 billion euros by 2027. The local e-commerce market has around 100 online shops, which register more than 1,000 orders per day.

Romania's Transgaz to start building 500 mln euro gas pipeline

Romania's natural gas transmission company Transgaz signed the order for the start of the construction of the Tuzla-Podisor pipeline that would link the gas resources exploited in the Black Sea offshore project Neptun Deep to the BRUA corridor via the national transmission system. The Tuzla-Podisor pipeline of 308.3 km in length is a project worth an estimated 500 million euro (\$548.4 million). The pipeline is on the list of EU projects of common interest and obtained financing of 85 million euro, with the difference to be covered through a competitive financial mix. The Tuzla-Podisor gas pipeline is also necessary for the transportation of the 15 billion cubic meters of natural gas that would come to Romania from the Caspian Sea area, via LNG terminals in Turkey and Greece.

Romania's Exports of Tobacco Products Increased In 2022 By Over EUR 140 M

In 2022, Romania's processed tobacco product exports, including cigarettes and consumables for tobacco heating, reached 1.48 billion euros, a 140 million euro increase from the previous year. BAT Romania, the largest local tobacco market player, exports around 70% of its production from Ploiesti, with over 500 million euros invested. Raw and processed tobacco imports were approximately 375 million euros, maintaining a positive trade balance contribution of over 1.1 billion euros. BAT Romania also contributed significantly to the state budget, paying around 10.5 billion lei in taxes and excises in 2022.

Over the past decade, tobacco product exports tripled, reaching almost 1.5 billion euros in 2022, making up about 43% of total food, beverage, and tobacco exports. With a market share exceeding 50%, BAT's 25-year presence in Romania had an economic impact of over 125 billion euros, including about 24 billion euros in direct contributions to the state budget. Employing 3,000 people and indirectly generating 30,000 more jobs in distribution and supply chains.

Bucharest Exchange-listed winemaker invests in own PV energy generation capacity & CIECH Soda adds 400kWp PV park to its Romanian factory

Bucharest Exchange-listed Purcari Wineries announced that it continues its efforts towards sustainability by extending its PV system located at Purcari Winery and installing a new system on the premises of Bostavan Winery. The existing solar panel system installed in 2022 on the rooftop of Purcari Winery's production site was extended with an additional 300 kW. Now comprising a total capacity of 500 kW, the system will supply 40% of the winery's annual electricity consumption.

CIECH Soda Romania, a subsidiary of the Polish CIECH group, announced it started the production of solar energy, following an investment of RON 1.7 million (EUR 340,000) in a photovoltaic park. The production facility spans a surface of nearly 2,000 square metres.

The annual rate of inflation decreased to 10.64% in May 2023

The annual rate of inflation decreased to 10.64% in May 2023, from 11.23% in April 2023, as food goods rose in price by 18.73%, non-food goods by 5.15%, and services by 11.16%, according to the latest National Institute of Statistics report.

Romanian Toy Market, Record Level of Over 1.7 Billion Lei In 2022

Romanian toy market turnover soared by 14% in 2021, reaching an all-time high of over 1.5 billion lei and continued to grow in 2022, surpassing 1.7 billion lei. This remarkable growth was attributed to the expansion of the product portfolio, incorporating interactive and educational technologies, and the development of the green toys segment. Additionally, inflationary pressures influenced consumer behavior.

JUMBO EC.R SRL, a Greek-owned company, maintained its position as the leading seller with a turnover of approximately 901 million lei (69% of total trade) after a 9% annual increase. Noriel (INTERTOY ZONE SRL), a company with Turkish shareholders, secured the second spot with a turnover of 258 million lei, accounting for 20% of total trade. BRICK DEPOT SRL, the local distributor of Lego, ranked third with 37 million lei (2.8% of total trade), followed by LUXPRIMM SRL (17 million lei; 1.3%) and J&M SRL (12 million lei; 0.9% of total local trade). The top 5 companies collectively contributed 93% of the total toy market turnover in Romania in 2021.

Romania, among top wheat importers and exporters in 2022-2023 season

In the 2022-2023 season, Romania ranked second in wheat imports and exports in Europe, with 0.89 million tonnes imported and 3.96 million tonnes exported. However, maize imports reached 1.34 million tonnes, and exports stood at 1.64 million tonnes. These figures come after a weak year of wheat production, only 55% of the previous year's volume, but a more optimistic 2023-2024 season is expected due to increased global production and improved weather conditions. The downward trend in wheat and maize prices might see a slight recovery in the future. Romania's importance as an agricultural production center and logistics hub is growing, despite challenges posed by competition from cheaper Ukrainian grain.

Industrial production prices grew by 11.6% in April

Industrial production prices (domestic and foreign markets) grew by 11.6% in April 2023, against the same month of 2022, but dropped by 3.5% compared to March, according to data published by the

National Statistics Institute. The most important price rises of industrial production in April 2023 versus April 2022 were in: energy industry (+19.02%), intermediate goods industry (+2.99%), durable goods industry (+9.88%), capital goods industry (+6.55%) and houshold appliance industry (+14.47%).

World Bank sticks with moderate growth forecast for Romania

The World Bank has not changed its 2.6% estimate issued in January regarding the growth rate that would be recorded this year by Romania's economy, according to the latest edition of the "Global Economic Prospects" report published on June 6. The WB expects Romania's economy to slow down this year from the 4.7% growth reported in 2022. It has also revised down from 4.2% to 3.9% the expectations for next year's growth.

Romania's Foreign Exchange Reserves Mount To Over EUR 53 Billion

National Bank of Romania's foreign exchange reserves stood at EUR 53,082 million on May 31, 2023, compared to EUR 53,341 million on 30 April 2023, so slightly down.

Moldova to buy and store half of its natural gas stock in Romania

Moldova will store half of its natural gas reserves in Romania, ensuring energy security for the next winter. With Moldova lacking gas storage capacity, they signed contracts with suppliers, and around 25 million cubic meters (265 GWh) will be stored in Romania initially. Romania is committed to being a long-term energy partner, and the gas will likely be purchased from OMV Petrom and stored by Depogaz. Additionally, the Romanian Electricity and Natural Gas Market Operator (OPCOM) will open a branch in Moldova, bringing advantages like a functional energy exchange in the country.

European Parliament's Committee on International Trade approved one- year extension of tax suspension for imports from Moldova

The European Parliament's Committee on International Trade voted for a one-year extension of the suspension of import duties and quotas on Moldovan exports to the EU. The decision aims to help Moldovan products affected by the war in Ukraine, and it significantly boosted Moldova's exports to the EU. The final vote will be in the Parliament's plenary session in early July, ensuring adoption before the current suspension expires on July 24, 2023. MEP Siegfried Mureşan supports this measure and suggests that the next step should be the permanent liberalization of trade between Moldova and the EU.

Moldova signs Free Trade Agreement with states of European Free Trade Association

Moldova signed a Free Trade Agreement with the European Free Trade Association (EFTA) states (Iceland, Liechtenstein, Norway, and Switzerland) on June 27, 2023. The agreement aims to strengthen economic cooperation, facilitate trade of goods and services, and reduce customs duties on Moldovan farming products for export. Additionally, Moldova will eliminate all customs duties on imports of industrial products. The agreement also includes provisions for electronic trade. Prime Minister Dorin Recean described it as a historical moment that will bring several benefits to Moldova, including increased investments, job opportunities, higher exports, diversification of commercial partners, economic stability, and better integration into the European market. The negotiations started

in 2017 and concluded after five rounds and multiple discussions between 2021 and 2023. The agreement offers significant growth potential for Moldovan exporters and enhances the country's economy by accessing a quality commercial environment with a diverse consumer base. The value of imports and exports between Moldova and EFTA states in 2022 amounted to 122.84 million dollars.

EU invests 250 million euros for improving cross-border connections between Moldova, Ukraine, their neighbours

The European Union will allocate 250 million euros to finance cross-border connection projects between Ukraine, Moldova, and their EU neighbors (Romania, Hungary, Slovakia, and Poland). This funding is part of a larger EU program comprising 107 transport infrastructure projects across Europe, receiving grants totaling over 6 billion euros. The investment aims to advance the Trans-European Transport Network (TEN-T) and enhance solidarity corridors, facilitating the transportation of goods between the EU and Ukraine. The financing will be provided as grants to co-finance the overall project costs, selected in response to the demand for projects published in 2022. European Commissioner for Transport Adina Valean expressed satisfaction with the allocation, emphasizing the importance of improved cross-border connections in the region.

Moldova to receive 120 million euros for reforming energy sector

Moldova signed a Memorandum of Understanding with the French Development Agency (AFD) to receive a 120 million euro loan for energy sector reform projects. The first 40 million euro installment will be disbursed by the end of the year. Additionally, Moldova will benefit from a technical assistance program with a 5 million euro donation from the European Commission's Neighbourhood Investment Platform. The funding will be used to implement projects over the next five years, focusing on de-carbonization, energy optimization in buildings, electric public transport, and integrating renewable energies into the network. The AFD's executive director emphasized the importance of aligning the energy sector with European standards to enhance security of supply, develop renewable energy sources, and promote energy efficiency. The memorandum was signed between AFD and various Ministries, aiming to accelerate Moldova's integration into the EU on the energy dimension.

Top international bank to provide Moldova with financial assistance worth over 126 million dollars

The International Bank for Reconstruction and Development (IBRD) will provide Moldova with financial assistance worth 126.4 million dollars. The draft laws which envisage the ratification of agreements on financing today were considered at meetings of the parliamentary commission for foreign policy and European integration and the one of the parliament's commission for economy, budget and finances.

Moldova will benefit from grants worth 34.3 million dollars and a loan amounting to 92.1 million dollars. The financial assistance is meant for the stabilization and growth of Moldova's economy, as well as for implementing social and economic programmes contained in the government's agenda of

reforms. The ratification of the agreements on financing between Moldova and IBRD will be proposed for consideration in the parliament's plenum.

World Bank supports Moldova's sustainable development in European integration way

Moldovan Prime Minister Dorin Recean and World Bank's Regional Country Director for Eastern Europe Arup Banerji discussed economic governance, public service modernization, combating corruption, and improving the business environment and labor market during a meeting. The PM expressed gratitude for the World Bank's support in carrying out systemic and structural reforms, particularly in ensuring energy security. Banerji reaffirmed the World Bank's commitment to supporting Moldova's development in various sectors, with over 1.3 billion dollars allocated since Moldova's accession in 1992, covering areas like regulation reform, education, infrastructure, health, and more. Currently, 12 active projects are ongoing with a total commitment of 617 million dollars.

EU to provide grant worth 40 million euros for Moldova's economic improvement

The government approved a draft law to ratify the agreement between Moldova and the European Commission for EU's programme on resilience and governance. The agreement, signed on May 11, 2023, provides non-refundable assistance worth 40 million euros. The assistance aims to strengthen state and societal resilience, support social and economic improvement, promote good governance, stability, peace, and inclusivity. The funds will be utilized for developing human capital, promoting gender equality, ensuring national stability, territorial integrity, and creating sustainable and resilient agro-food systems. The agreement is part of the EU's Annual Action Plan for 2022 for Moldova, financed through the Neighbourhood, Development, and International Cooperation Instrument (NDICI) - Global Europe, for the 2023-2026 implementation period.

World Bank to help Moldova with 55 million dollar-loan for agricultural development

Deputy Prime Minister and Agriculture Minister Vladimir Bolea, along with World Bank Country Manager for Moldova Inguna Dobraja, signed a Loan Agreement with the International Bank for Reconstruction and Development (IBRD) for the Agriculture Governance, Growth, and Resilience Investment (AGGRI) project. The financing program is valued at 55 million dollars and will be implemented in Moldova until 2029. The investment will focus on developing low-efficient agricultural areas, creating job opportunities, promoting sustainable practices, and environmentally friendly production. Part of the funding will be offered as grants to farmers, supporting initiatives in the livestock and horticultural sector, while another portion will be allocated to rehabilitating primary and secondary irrigation infrastructure. This project aims to foster sustainable agricultural development and strengthen cooperation between the World Bank and Moldova in agricultural reforms.

Albania uses the Harmonized Code System for tariff classification. The customs duty rates range from 0% to 15%, depending on the type of goods. Import of machinery and equipment for use in the taxpayer's business activity are generally subject to customs duties at the zero rate. Import of vehicles are subject to customs duties at a rate of 0%.

Excise duties

Excise duty is a tax applicable to certain goods consumed in Albania, whether imported or produced in the country. Albanian excise legislation is based on EU Council Directive 2008/118/EC, which defines common provisions applicable for all excisable goods. It also integrates specific provisions applicable for each category of excise products. Categories of products subject to excise duty in Albania are:

- •Energy products (e.g. petroleum, gasoil, gas).
- •Tobacco products (e.g. tobacco, cigarettes).
- •Alcohol and alcoholic beverages (e.g. beer, wine, spirits).
- •Other products (e.g. baked coffee, fireworks).

Excise duty is usually calculated as an amount per quantitative measuring unit defined for that product (e.g. per litre, per kilogram, per hectolitre, per 1,000 pieces).

Dairy in Albania Costs 11.7% More than European Average

Albania, with around 20% of its GDP coming from the agricultural sector, has one of the highest dairy prices in Europe. In 2022, dairy and egg prices were 111.7% of the EU average, resulting in a per capita expenditure of 324 euros per year for Albanians. Over the last three years, while prices decreased in many European countries, Albania saw an increase of 6.8 percentage points. This poses challenges for affordability, as dairy and eggs are essential in the recommended daily nutrition by the World Health Organization

Tourism-Related Businesses Grew Significantly in 2022

The tourism sector in Albania has experienced rapid growth due to an increase in foreign visitors, leading to the expansion of businesses in the accommodation industry. In 2022, the number of hotels increased by 23%, reaching 2,005 businesses. However, there is high informality within the tourism sector. Although the business turnover grew significantly, the sector's contribution to paid employment remained unchanged. Around 1.3 million people were employed in the sector in 2022, but only 755,000 were reported to be salaried. Hotels and restaurants contributed 5.3% to total paid employment, the same as in 2021, but their contribution to the economy's turnover rose to 11.8% from 2.3% in 2021. The number of foreign visitors reached a record high, with 3.64 million entering Albania in the first four

months of 2023, a 38.6% increase from the same period in 2022. However, the country faces challenges like infrastructure deficiencies and a shortage of skilled professionals to provide quality services.

IMF Mission Warns Economic Growth of 3% in 2023

International Monetary Fund (IMF) mission has evaluated the economic progress in Albania and growth is expected to reach 3% for this year. The International Monetary Fund emphasizes that the level of inflation remains a challenge for the economy even though there has been a downward trend. Meanwhile, the Monetary Fund appreciated the initiative to increase wages but at the same time suggests that measures be taken to improve the income in the budget.

Germany, France Offer EUR 100M for Energy Reform

The Albanian Ministry of Infrastructure and Energy signed a 100 million euro (\$106.8 million) policy support loan agreement with German bank KfW and French agency AFD to fund energy sector reforms. The focus will be on renewable energy, energy efficiency, and domestic market remodeling. The loan aims to promote climate-friendly energy production, contributing to the second phase of supporting the Albanian electricity sector, which faced an economic crisis and energy crisis in 2022 due to Russian aggression in Ukraine. The reform includes innovative policies and projects, such as the separation of the Electricity Distribution Operator and the establishment of the Albanian energy exchange. The country is progressing towards a free market, and foreign companies are participating in wind power production auctions. (Source: Various)

EUR 624 MIn Tourism Revenue Registered in 2023

Year 2023 seems to be an even better year for tourism than the previous ones. The latest data from the Bank of Albania show that tourist inflows in the first quarter of this year alone reached 624 million euros. The INSTAT data are also optimistic, as according to them, almost 1.7 million foreign visitors entered the country during the four months, twice more than a year ago. Last year, tourist inflows to the country reached record levels of 2.8 billion euros, while tour operators are optimistic that the figures will be even higher this year.

Meanwhile, the expenses of Albanians abroad for tourist purposes are also high, as according to the statistics of the Bank of Albania, in three months they have spent 435 million euros on their trips. So if we make a comparison of the difference between what was spent abroad by Albanians and what the tourists brought, the result is a surplus of 189 million euros, against that of 86 million euros a year ago. While the departures of Albanians in the first part of the year increased by more than 30%, as their number in the January-April period reached 1.9 million.

New Record of Direct Foreign Investments in Albania during Jan-Mar 2023

Foreign direct investments in Albania reached a record high of 308 million euros in the first quarter of the year, a 1.65% increase compared to the same period last year. Reinvested

profits played a crucial role, accounting for more than 53% of total foreign direct investments in 2022. The hydrocarbon sector attracted the highest inflows, followed by financial intermediation, real estate, and energy sectors. After a rapid recovery from the pandemic, the country experienced significant growth in foreign direct investments, with investments in the real estate market making a significant contribution. In the post-pandemic period, the property market has attracted a growing volume of investments from foreign citizens.

Banking Sector's Profit Remained at Highest Historical Levels in Jan-Apr 2023

The banking sector in Albania reported a significant increase in net profit for the first four months of 2023, reaching over 9 billion ALL, an 85% rise from the same period in the previous year. This led to improved profitability indicators, with the sector's return on equity reaching 14.58% and return on assets at 1.44%. The stability of the non-performing loan ratio indicates a positive trend for the banking sector. Despite challenges like high inflation and increasing interest rates, the Albanian economy has shown resilience, with positive growth and stable banking sector performance. The financial market appears more stabilized, with falling yields and gradual growth in interest rates on banking products. It is expected that the increase in interest rates by the Bank of Albania will continue throughout 2023

Albania Issues EUR 600 MIn Eurobond

The Albanian government has managed to get a loan worth 600 million euros in the international financial markets. This is a loan taken from international banks and has a 5-year maturity, while the yield of the bond is 6.125%. The insured amount was higher than the one planned by the government in this year's budget. This is due to the strengthening of the Albanian currency against the euro. The Minister of Finance Delina Ibrahimaj emphasized that the higher value came as a result of the liquidity situation.

The emission of the Eurobond in the international markets is the sixth that is taken by the government and is a real test for the Albanian economy as it reconfirms the confidence of the markets in the stability of the Albanian economy even in difficult times, after the impact of the earthquake, the pandemic and the price crisis. This debt will be used to repay matured obligations, while a remaining part will be disbanded to finance the budget deficit or investments planned for 2023. The issuance of the Eurobond may have other effects on the weakening of the European currency against the ALL at this moment. The Eurobond is a financial instrument widely used by states to meet liquidity or investment needs.

Electronic Communications' Market Grew by 5.4% in 2022

The electronic communications market in Albania experienced a 5.4% growth in 2022, with total income reaching 38.2 billion lek (334 million euros), the highest since 2016. Fixed communication services, particularly Internet and IPTV, contributed significantly to the increase in revenue. The market volume of fixed network services saw an 8.9% increase, generating 65% of revenues from the 7 main market operators. Around 80% of Albanian families had access to fixed-line Internet in 2022, surpassing the Western Balkans' average

penetration rate. The mobile services market still dominates with over 66% of total revenue, but its growth rates were lower compared to fixed services. Vodafone Albania holds the largest market share in terms of revenue, followed by One Communications and Albtelecom. The total number of mobile subscribers at the end of 2022 reached approximately 3.7 million, with each resident having about 1.35 SIM cards, higher than the European average.

EU Transfers EUR 72 Million to Albania as Part of Energy Support Package

The European Union has provided a EUR 72 million support package to Albania to address the socioeconomic consequences of the energy crisis. The package includes subsidizing energy prices for households and SMEs, financial aid for vulnerable individuals, and promoting diversification of energy sources through wind and solar investments and renewable energy legislation. The funds aim to stabilize electricity prices and assist in diversifying energy supplies. The EU's ongoing support to Albania's energy sector includes various projects, and it remains a strong partner in assisting the country's reforms and alignment with EU values.
