13. Analysis of Investment opportunities in Bahrain

Oil has already sent the panic waves across the Gulf Cooperation Council (GCC), with the prices hitting the rock bottom. And this trend has called for the diversification of Gulf Economy. Experts are of the view that education is a proper replacement for Oil as Bahrain has lot of advantages. The geographical advantages and religious ambiance of Bahrain make the island a place fit to become the hub of education in ten years time. Over \$ 200 billion will be invested to create 40,000 kilometers long regional rail transport corridor which connects the six Arab Gulf Co-operation Council member states. The project will require companies, manufactures, human resources and capital to the region. The market will get an extra sector in which to expand providing opportunities for both the public and private sector. A study on a railway connecting Bahrain and Saudi Arabia is expected to be completed by the end of March. Two routes have been proposed for an 87 km long rail link that will connect two stations on either side of water. This rail link is also a part of GCC railway network. Aluminium Bahrain has line 6 projects which will add 400,000 tonnes to the smelter's current capacity of more than 900,000 tonnes. The feasibility study for the project has been completed and approvals from authorities are expected by 2015. Once construction starts, the project will be completed by 2018. Other major infrastructure projects include a US\$2bn expansion of Bahrain International Airport unveiled in December, which will increase annual passenger capacity from 9m to 13.5m over the next five years and includes a new terminal and retail facilities. The Bahrain Airport Company has announced plans to award contracts for enabling works related to the airport upgrade in the first quarter of 2015.

New Rules that restrict big bonuses for bankers in Bahrain have been implemented by the Central Bank of Bahrain (CBB). CBB Rulebook on remuneration rules for licensed banks was brought in to better protect shareholders and other stakeholders. The new rules are fair and in line with international best practices, including those recommended by the Basel Committee. Among other things, the rules specify fixed and variable components of remuneration.

Bahrain Economic Development Board (EDB) has highlighted details of a new visa policy that allows nationals of more than 60 more countries to obtain a visa on arrival, bringing

the total number of countries with this option to nearly 100. The new visa policy will be implemented in 2015 and is a significant development, with the potential to affect over 2.5 billion people who can now obtain a one month visa on arrival, with the ability to renew for another three months. In particular, the new visa policy will further enable expatriates who do business in Bahrain, to easily travel in and out of the Kingdom more easily, as well as boosting the tourism industry. Bahrain's industrial policy aims at diversification of the base of national economy and lays emphasis on promotion of new start ups across all economic sectors using environmentally sound technologies as well as on improvement of productivity and development of human resources in the existing enterprises. Bahrain has been ranked highly by several international organizations and has a reputation for offering attractive industrial opportunities to local and international investors. This coupled with an efficient banking and communication system, absence of taxation & exchange controls and a friendly society makes Bahrain an ideal place to invest in and do business.

The Saudi Fund for Development remitted US \$ 448 mn for development projects as part of the GCC fund following six agreements with the Bahrain's Ministry of Finance. US \$ 200 mn of the funding is expected to go on housing and infrastructure projects in the Southern Governorate while US \$ 85 mn is allocated to education. Another US \$ 13 mn is understood to have been earmarked for various infrastructure projects and US \$ 27 mn to water-related initiatives.

20. Commercial, Economic and Political Report of Bahrain

Commercial (April 2015)

The Central Bank of Bahrain (CBB) has launched a new liquidity management service for Islamic retail banks. The *wakalah* instrument, launched on April 1st, allows Islamic retail banks to deposit excess liquidity with the CBB on one-week contracts. The CBB will then invest the money in portfolios containing Islamic bonds known as *sukuk*. The aim is to provide a mechanism for Islamic retail banks to invest excess funds with the CBB in a similar way to conventional bank. Bahrain has positioned itself as a pioneer in the sector, but faces serious competition from its Gulf Co-operation Council (GCC) neighbours and other countries such as Indonesia, Malaysia and Turkey. The release of the *wakalah* instrument suggests that Bahrain will continue to explore new avenues for development of Islamic banking, including ways to boost its return on equity.

Economic (April 2015)

The sharp fall in oil prices in recent months, particularly following OPEC's meeting on November 27th, is having a significant impact on the corporate sector in the Gulf Co-operation Council (GCC). Although only a relatively small number of local companies work directly in the oil sector, mainly providing oilfield services, the fiscal squeeze on governments, whose spending is the major driver of the region's economies, will have a wider impact. Separately, GCC companies may capitalise on a strong US dollar to continue their international expansion. Regional stockmarkets provide one perspective on the corporate outlook for 2015. The markets are quite different across the GCC in terms of sentiment and liquidity. Qatar and the UAE saw major gains in 2013 and the first half of 2014, while Bahrain, Oman and Kuwait were flatter over this period. However, all of the

markets have been visibly affected by the dramatic oil price slide from the second half of 2014 and into 2015, although governments' refusal to rein in spending in response has provided some support since December. The relationship is complex, but there has been a 95% correlation between movements in oil prices and the Bloomberg GCC 200 Index (which tracks 200 of the bloc's largest companies) since early September 2014, when Brent crude oil fell below US\$100/barrel.

Although the falling oil price has some implication for domestic markets, there are other trends to watch out for in the GCC corporate sector. In recent years there has been a growing push by the region's larger companies to leverage their sizeable capital base to expand abroad, particularly in areas such as finance, telecommunications, power and real estate

Political (April 2015):

The first round of Bahrain's parliamentary elections took place on November 22, with the second round held on November 29, 2014. With the elections boycotted by the Shia opposition and marred by low-level violence, Bahrain's political impasse looks set to continue for the foreseeable future. It was announced end of 2014 that Bahrain will host a permanent British military base for the first time in more than 40 years. The Kingdom is already home of the US Fifth Fleet.
